**KRS 161.780 Termination of contract by teacher or superintendent- Resignation binding as of date of acceptance**

(1) No teacher shall be permitted to terminate his or her contract



within fifteen (15) days prior to the first instructional day of the school term at a school to which the teacher is assigned or during the school term without the consent of the superintendent.
