Over the past few months, several incidents have happened that caused me to spend some time reflecting on

our association. What caused these incidents? Does KEA-R have a clear understanding of its role in public education? How are we serving our members? Is there a common denominator among these issues? After pondering various possibilities, I have come to

believe these incidents stemmed from our ability to communicate or the lack thereof.

As of August, I have been a KEA member for fifty years. Through those years we have had multiple committees, task forces, etc. that have tried to design a better KEA. Each group has talked about communication as the weakest link in our function chain. Over and over, we have tried to address the issue but the issue remains. Why are we not getting information out to members and maybe more importantly, why are members not getting information back to elected leaders?

In his book, Promises of Work, Matthew O'Neil offers five reasons why communications fail.

- 1. **Communications are overwhelming**---too many messages---too many channels. To address this, I will only communicate via three channels. You will receive 4 editions of our award-winning newsletter, KEA-Retired Today/Tomorrow. These should arrive the weeks of Sept. 13, Dec. 10, March 7, and May 6 and should contain both state and area content. Any action that will require immediate notification will be transmitted via Constant Contact/email. The KEA-Retired Facebook page will be utilized to share informational items on an as needed basis.
- 2. **Messages are inconsistent.** Every attempt will be made to keep all publications congruent. We must convey the same message no matter the format or the audience.
- 3. **Communication is unclear, inarticulate.** I am not a writer by trade but will attempt to use specific, precise language.
- 4. **Not enough listening or compromise.** Call me, send me a text, drop me an email. I will listen and attempt to understand your point. Let's have a conversation. If I am not available, leave me a voice mail, I will return your call. Send me an email. I will respond. Your thoughts and or questions are important.
- 5. **Lack of trust.** KEA-Retired tries to keep all actions clear and transparent, as do I. We never intend to go to the dark side with any of our actions. It is our intent to earn your trust.

Some say, the goal of communication is to express one's self to gain knowledge. My promises stated above tell how I will be expressing myself but I can not gain knowledge without help from you.

Your help is needed. KEA-Retired frequently uses the KEA election process to elect district officers, KEA-R board members, and our delegates to the KEA DA and the NEA RA.

In June, KEA adopted a new electronic election process. Before the election opens, Kathy Whitlock will create a file containing Last Name, First Name, membership ID #, and email address for all eligible voters. This file then goes to John Lynch who creates the voting opportunity. The member will receive an email from **simplyvoting.com** announcing his/her registration for the election, providing the link to the electronic ballot, his/her elector ID, and password as well as the ending date for the election.

To enable you to vote electronically, we must have a **valid email address** for you. These must be personal emails. None with the extension .edu or .gov will be accepted. School emails will not be recognized by the system. If you have not provided your personal email address, please go to www.kearetired.com and do so. There is a form on the landing page that will allow you to enter your personal email address. You may also send your personal email address to Kathy at Kathryn.Whitlock@kea.org.

A free, personal email account may be created at either <u>www.gmail.com</u> or <u>www.yahoo.com</u> should you desire to do so.

If you prefer to cast paper ballots rather than vote electronically, we will provide information to obtain a paper ballot for any election for which you are an eligible voter.

Virtual Governance

And, just how did you spend your summer vacation? Resting? Reading? Watching family members at the pool? Enjoying the outdoors? Gardening? Here is how seventeen of your fellow KEA-Retired members spent part of theirs.

NEA-Retired works within NEA to support public education and to advocate for issues affecting retirees. Governance decisions occur at the Annual Meeting. Our 17 delegates fired up their computers on June 23rd ready to make the decisions necessary to support this work. A new virtual platform made participation much easier than in the past but as with most things virtual, glitches sometimes occurred. The business of the association included raising over \$29,476 during the meeting for the NEA Fund for Children and Education to be used to support the election of persons friendly to public education. This helped push the amount of money raised during the 2020-21 association year to a new high-\$250,028.84. Walt Munsterman, Michigan, was named the 2021 NEA-Retired Distinguished Award recipient. To improve the functioning of KEA-R, governance documents were reviewed.

Jack Kinnaman Memorial Scholarships in the amount of \$2,500 each were presented to five deserving NEA Aspiring Educators. Jack passed while serving as Vice President of NEA-Retired during Jim Sproul's term as president. Contributions to the scholarship fund during the meeting totaled over \$4,256. An action of the KEA-Retired Board allowed KEA-R to make a \$500 contribution to support the giving of these scholarships. 36 scholarships totaling over \$65,000 have been awarded.

An important component of the Annual Meeting is selecting the officers who will manage the day-to-day functioning of the association. The virtual nature of the meeting demanded a secure ballot be mailed to each participating delegate. Given the slowness of surface mail, this process took about 3 weeks to complete. These ballots have been counted. Marilyn Warner-FL will be the secretary for the coming 3 years. Barbara Schram-MI and Anita Gibson-AL were re-elected to represent retirees on the NEA Board of Directors. Janet Kilgus-IL will serve as alternate to the NEA Board of Directors. Meg Gruber-VA and Janice Poirier-FL were elected to the NEA-R Executive Committee.

Early evening, June 24th, our delegates shut down their computers happy to have represented you and confident that they had made the decisions KEA-R members would have desired. They were ready to rest their eyes and overcome their zoom fatigue but the virtual NEA RA was on its way

On June 30th, KEA President Eddie Campbell called the first KY NEA RA Caucus to order. This was followed by 3 intense days of virtual meetings. The KY caucus re-elected Alan Young and Alvia Littleton to serve on the 2021-22 NEA Resolutions Committee. The caucus was able to discuss all the constitution/Bylaw amendments, the amendments to the legislative program, amendments to NEA policy statements, and the amendments to the NEA Resolutions. Sixty-five new business items were presented to the delegates. Some passed, some were referred to committee and others were defeated. Bylaw amendment 2 has an immediate impact on KEA as it reduces the continuous retired membership cost of active ESP members as they retire. Until this summer, retiring ESP members were charged the same NEA-R dues as retiring certified members. Bylaw 2 as amended reduces cost of ESP retiring dues to 60% of that paid by retiring certified members.

Delegates to the NEA RA heard presentations from President Joe Biden and First Lady Jill Biden, Education Secretary Miguel Cardona, Stacy Abrams, NEA President Becky Pringle, and NEA Executive Director Kim Anderson. Delegate Janet Jackson mentioned how proud she was to hear Stacy Abrams give a shout out to Kentucky for our bipartisan voting plan used during the 2020 general election.

A high point of any NEA RA occurs when the honored members of the year are introduced to the delegates. Juliana Urtubey, an instructional strategist from Las Vegas, is the 2021 National Teacher of the Year. She stressed the need for collaboration and resilience. The National ESP of the Year is Kimberly Scott-Hayden. She has worked tirelessly to help the 200,000 New Jersey NEA members build a better world for their students. A counselor was named the Higher Ed Educator of the Year. Julius Thomas, Rio Hondo (CA) College, works to show students the dedication, perseverance, and ambition he witnessed during his educational experience.

A disability rights activist, Judith Huemann, received the 2021 NEA Friend of Education Award. As a young student she was prohibited from attending public school and received only homebound instruction. The principal of her elementary school called her wheelchair a "fire hazard." This experience led Ms. Huemann to devote her life to advocating for the rights of individuals with disabilities, improving life for millions of marginalized children and adults.

Six members offered themselves as candidates for the NEA Executive Committee: Ronald "Duff" Martin-WI, Gladys Marquez-IL, Michael Wesley, Jr.-AL, Mark Airgood-CA, Tonia Kappner-CA, and our own Matthew Powell who did a great job presenting himself as a candidate and representing KEA. Gladys Marquez and Ronald "Duff" Martin were elected. Matthew is a great guy who values students and understands the importance of membership in NEA/KEA/and his local EA. Matthew Powell thanks for running for office. KEA-R is proud of you and your accomplishments.

GPO WEP UPDATE



H.R. 82, the Social Security Fairness Act would fully repeal the Government Pension Offset (GPO) and the Windfall Elimination Provision (WEP). The bill has 138 co-sponsors. It has been referred to the House Ways and Means Committee due to its estimated cost --- between \$80 and \$90 billion over ten years. The question has been raised about its hitching a ride with any of the COVID packages but this not likely. These packages were passed along party lines and are subject to the rules around reconciliation. Social Security is off limits in reconciliation. The short answer is getting it to the floor for a vote will be an uphill climb. That said, we can help by calling our Members of Congress. This is one of the few bipartisan bills currently in play. A WEP-only bill that Chairman Richie Neal has introduced, H.R. 2337, the Public Servants Protection and Fairness Act would start

to repeal the WEP penalty. This bill currently has 46 cosponsors. This legislation would give current retirees, on average, an additional \$150 per month. Future retirees would get on average, \$75 more per month in benefit. No one would get less than they are getting now. While NEA supports the bill, our real push is to pass H.R. 82/S.1302 which would fully repeal both the GPO/WEP.

Many, many thanks to KEA President Eddie Campbell for joining NEA President Becky Pringle and 11 other NEA state affiliate presidents in sharing the importance of this bill with Richard E. Neal, Chair, Committee on Ways and Means, US Host of Representatives. And to our representatives who have all signed on to the bill.

TRS WILL NO LONGER DEDUCT KEPAC CONTRIBUTIONS FROM YOUR TRS PENSION.

Nominations for 2022 KEA-Retired delegates to KEA Delegate Assembly and NEA Representative Assembly

The KEA Delegate Assembly will be held April 7 – 9, 2022 at the Galt House in Louisville. KEA-Retired may have as many as 110 delegates to the assembly. (The exact number will be known when membership is verified on November 15, 2021). If you wish to serve as a KEA-Retired delegate to the KEA DA, fill out the nomination form on the facing page and return it to Kathy Whitlock, KEA-Retired Associate Staff. Nominations must be postmarked no later than October 9, 2021.

KEA-Retired to the Delegate Assembly will receive up to \$300 plus mileage (currently 57.5 cents per mile). Receipts are needed for every expense occurred. Delegates must attend all sessions.

Nominations are also open for delegates to the NEA Representative Assembly. The NEA RA will be held in Denver, CO., July 2 – July 6, 2022. Delegates are also expected to attend the NEA-Retired Annual Meeting which will be held in Denver immediately prior to the NEA RA. KEA-Retired may have as may as 18 delegates to the NEA RA. (The KEA-Retired President is an automatic delegate).

If you wish to serve as a KEA-Retired delegate to the NEA RA, fill out the nomination form on the facing page and return it (postmarked no later than October 9, 2021) to Kathy Whitlock, KEA-Retired Associate Staff.

KEA-Retired delegates to the NEA RA will receive up to \$1,650 toward expenses for attending the NEA RA and up to \$700 toward expenses for attending the NEA-Retired Annual Meeting. Receipts are for all expenses occurred from the meetings. A written report is required with expense voucher.

Participants are expected to attend all sessions of the NEA-Retired Annual Meeting, all sessions of the NEA RA and any caucuses held by the Kentucky delegation.

If elected, delegate's expenses will be

reimbursed up to \$1650.00 (plus mileage) in return for attendance at ALL delegates business

sessions and Kentucky caucus meetings.
