Are We in Danger of Losing Teaching as a Profession?

Sometime in the second half of the 20th century, we danced out of our teacher preparation programs clutching our diplomas and our teaching certificates. We were headed out to make a difference for each student we taught. As we began to share the content we had learned and implement the strategies we were taught, we realized

that we needed to learn much more.

Just why were all our students not performing at the desired level? What could be done to reach those who were seemingly unreachable? How could our teaching skills be improved? Would learning from each other be possible?

We pursued the latest in brain theory---adding experiences to our curriculum delivery that helped engage the adolescent brain much more deeply. We studied the impact that poverty has on a child's ability to learn. Again, we refurbished our curriculum by differentiating our instruction thus addressing the gaps in prior experiences our students had. Oh my, then came the advent of technology. Did that ever shake up the teaching profession and the student's learning environment! Once more we made changes in our daily work as well as that of the students, all with the intent of students learning the content more deeply.

Along the way, we became advocates for our students and our chosen profession. We knew how to adapt to the students' needs and we knew how to explain the "whys" of the curriculum we had designed within the parameters provided by the Kentucky Academic Standards. In fact, we still do. We may need to quickly share our understanding of teaching and learning with current policy makers.

Let's not forget, the Kentucky Academic Standards define the content Kentucky's students are to learn. They were developed with input from educators, business leaders and parents. Our teachers understand that the Standards are what our students need to know to achieve their desired measures of success and are well equipped with the skills needed to reach their students.

As your president, I regularly attend the House Education Committee and the Senate Education Committee meetings. Their conversations lead me to believe the pendulum is swinging from the well-prepared teaching professional working in concert with parents to design quality educational experiences toward presenting highly defined content determined by legislative actions and groups of vocal parents delivered under strict parameters. This has the potential of reducing access to content our students deem relevant and to delete teaching strategies that make the content come alive.

Today, as I waited to enter the Capital Annex, I overheard an area teacher talking about the number of teaching professionals that had left the local school system recently. This took my mind back to a similar conversation a couple of months ago with personnel directors of two small school districts in southcentral Kentucky. They, too, expressed that many teachers were leaving their systems at the end of the first semester----leaving the profession. . . quitting. . . not retiring. My daughter helps a college sorority with 119 members. Not one of these young ladies is preparing to teach. Current teachers are leaving; future teachers are not being developed. Could the de-professionalism I described above be part the reason?

What can we as retired educators do? We can share how we used professional autonomy to design experiences that helped our students internalize the content found in the Kentucky

KEA-Retired Annual Meeting

It is that time again, the KEA-Retired Annual Meeting is coming soon. This face-to-face meeting will be held April 6 at the Galt House in Louisville. This is your opportunity to impact directly the work of KEA-Retired while reconnecting with your past association friends.

The day will begin with on-site registration at 11 a.m. ET, followed by a buffet lunch at noon. The business meeting will begin at 3:00 p.m. ET.

Highlights of the meeting will include the presentation of the Tom Denton Memorial Scholarship as well as the KEA-Retired Friend of Education Award. Two constitutional amendments will be considered for adoption. The text of these follow at the end of this article.

An election will be held to fill one seat on the KEA Board of Directors. Should amendment 1 pass, an election will be held to fill a treasurer's position. We will also elect a retired member to represent us on the KEA Budget Committee. Any member of KEA-Retired may run for one of these positions. Nominations will be made from the floor. If you are interested in the responsibilities of these positions, contact either Kathy Whitlock or Brenda McGown.

All KEA-R members in attendance will have the opportunity to contribute during debate, to submit new business items, and to participate whenever votes are taken.

There is no cost to attend this general meeting. **But, we ask that you notify Kathy Whitlock at** <u>Kathryn.Whitlock@kea.org</u> **of your intent to attend.** This allows us to prepare enough materials and order ample food to provide your lunch.

This meeting serves as the pre-delegate caucus for the KEA-Retired delegates to the KEA Annual Meeting. Consequently, our elected delegates are expected to attend.

KEA-Retired Constitutional Amendment 1 was provided in its entirety in the last KEA-R newsletter. Here is a synopsis of how it would impact our association:

- Provide for the election of an executive officer, a treasurer, to fill a 3-year term
- The treasurer shall maintain the financial records, prepare financial statements, approve with associate staff all expense vouchers other than his/hers, prepared all checks needed to pay expenses other than his/her own, serve as a member of the KEA-R Budget Committee, and work with the selected professional to file required state and federal tax documents
- The president, along with associate staff will approve voucher of treasurer then write checks to him/her

KEA-Retired Constitutional Amendment 2

ARTICLE VII DISTRICT DIRECTORS

SECTION I. KEA-Retired members from each KEA-Retired district shall elect (1) District Director for each 600 800 KEA retired members or major fraction thereof.

RATIONALE: The current ratio produces a board that is cumbersome and not able to meet in provided locations.



The prescription formulary for the Medicare Eligible Health Plan changed January 1. This caused some fluctuation in what medications are covered as well as increases in copays for some medications. The Medicare monthly premium increased by \$15 over what had been expected. This impacted all retirees due to shared responsibility (the process used to fund the medical health trust). We are in the middle of a perfect storm – inflation much higher than we have seen, insurance premiums increasing, and confusion over availability and cost of medications. KEA-RETIRED BOARD NOMINATIONS DUE MAY 1

The following districts are due to elect new representatives for the KEA-Retired Board of Directors: Second, Third, Fourth, Fifth, Central, JCTA (2), MCEA, NKEA (2), and UCEA.

*Second, Fifth, JCTA and NKEA will elect an additional director due to growth.

The directors from Fifth, CENTRAL, NKEA and UCEA are eligible for re-election.

Directors elected by District KEA-Retired members serve a two-year term on the KEA-Retired Board and are limited to two (2) consecutive terms. Directors elected will serve from June 15, 2022 through June 14, 2024.

The KEA-Retired Board meets at least five times a year, usually at KEA Headquarters in Frankfort. District directors are expected to help organize district meetings and political activities, serve on committees, promote active and retired membership and report district news for use in the KEA-Retired newsletter.

*All nomination forms are due by May 1, 2022. Should Amendment 2 be adopted at the annual meeting, this list will change. Appropriate notification will be made.


Oh The Places We'll Go... You Could Go To

It happens standing in the line at Kroger, across the gas pumps and from table to table at the steakhouse (well pre-virus), people see you and ask "Heard you retired, miss teaching?" If you're like me, you have an answer and it usually ends with "but I sure miss the kids. It's a common denominator in most retiree's conversation. Don't miss the meetings, the lesson plans and the early mornings and late evenings, but we miss the kids. Another given is that it is just hard to corral retired folks long enough to get them involved in the district activities. So pair the two and try this project with your district.

Destination Read was born when Fifth district leaders were looking for a way to engage members, connect them to the active teacher in the classroom and connect with kids! A year later we have made five school wide visits and connected with best guess over 650 kids of elementary age!

It's really pretty simple. We invite and engage retirees who are interested. They pledge to give up about 2 hours, buy a grade appropriate hardback book and an item that is directly connected to the book. (For example, one teacher chose to read Where Is Green Sheep? to kindergarten kids and bought a green sheep stuffed animal to the reading. The district then adds pencils and bookmarks and a ribbon tied bundle of Sharpie's with a colorful note that reads "Thank you for Making a Mark in the Lives of Children!" All the books are labeled with a district sticker reading "Provided by a public school retired teacher"!

Behind the scenes it's a little more work. An active KEA teacher from the building takes on the task of meeting with the principal, engaging teachers who want a reader, and building a schedule that honors the school schedule and gets the approval of the principal. When reading day rolls around, retirees gather and the excitement is palatable. Readers meet their class, read the book they selected to share engaging the children as they read. They present the book and items to the classroom teacher and goodbyes and smiles abound! Some retirees opt to read to multiple classes. Some read picture books and some a couple of pages in a chapter book. In most cases, schools ask for a return visit and best of all teachers say that the kids are eager to check the book out and take it home to share! One reader reads a book to Kindergarteners entitled Where is Green Sheep?, she keeps the stuffed green sheep in a bag till the end of the story and the kids are charmed lining up to take a turn holding him. Another teacher dresses like Humpty Dumpty and reads the book After the Fall. The kids are enthralled with what Humpty did after his fall, eager to tell the story of when they had booboos and were hurt too It's been a great project and although we were unable to read to several schools we had planned to visit this year. There's always Humpy Dumpty, Green Sheep and next year...















Synopsis of Business---February 16, 2022 KEA-Retired Board of Directors Meeting

- ✓ Eddie Campbell-KEA President, Joel Wolford-KEA Vice President, and Michael Wilson-KEA GR Staff shared current actions of KY General Assembly
- ✓ Lisa Petrey-Kirk provided financial information showing that KEA-R has a current balance of \$415,095.60 with no outstanding bills.
- ✓ Charlotte Benton, chair of the audit committee, presented a written audit report showing that the financial records are in order. She recommended that a monthly reconciliation of the bank statement with the checkbook should occur. She also recommended establishing a deadline for checks written to be cashed. The Board added the recommendations to the KEA Board Policies after amending the 3rd one. Checks must be cashed within 60 days of receipt. Notification of this policy will be placed on all vouchers and checks.
- ✓ Approved/amended constitution committee's suggested constitution amendment to change the ratio of district directors to 1 director for each 800 members. This will be voted on at the annual meeting in April.
- ✓ Made housekeeping changes to KEA R Board Policies.
- ✓ Received the recommendations for Tom Denton Memorial Scholarship and KEA-R Friend of Education award. These will be announced at the annual meeting.
- ✓ Reviewed tentative plans for the KEA-R Annual meeting at the Galt House, April 6
- ✓ Communications Committee presented various topics for articles to be included in future newsletters.
- ✓ PAL Committee suggested reactivation of the KEA-R O Cs (KEA-Retired on Call)—collect contact information for those members within driving distance who are willing to appear at legislative committee meetings, rallies, etc. upon short notice.

A complete set of minutes will be available upon request to members upon their approval at the next KEA-Retired Board meeting.
