Dear Member:

Please find a summary of the past week's legislative events here.

Due to the President's Day holiday on Monday, the legislature started their week yesterday and there was no House Education Committee meeting. Chairwoman Huff has called a meeting of the House Education Committee to begin upon adjournment of session today. Anyone that can get to Frankfort after school **today** to attend this meeting is encouraged to do so.

Another important bill we are watching is <a href="HB 58">HB 58</a>. This bill is co-sponsored by legislators on both sides of the aisle. It amends KRS 141.019 to increase the pension income exclusion from \$31,110 to \$41,110; apply retroactively for taxable years beginning on or after Jan. 1, 2018; require the Department of Revenue to automatically issue refunds; EMERGENCY. KEA SUPPORTS this bill and asks that you contact your legislators to ensure its passage. Be sure to contact the chair of the House Appropriations and Revenue Committee and <a href="email Rep. Rudy">email Rep. Rudy</a> to hear this bill in committee.

We need all public-school employees to continue to call their Representative to OPPOSE HB 205, a bill that would give tax credits to those that choose to send students to private schools. ### TELL Survey in limbo this year

Many members have asked me recently, "Are we doing the TELL survey this year?" The answer is: MAYBE. As of this writing the New Teacher Center, the company that has administered the survey in the past, has decided to no longer sponsor this survey. The KDE has put out a new RFP for others to serve in this capacity, but this process is still open. Communication from the Department of Education suggests that IF the survey is given, it will happen no earlier than the fall of this year. I will communicate more details about this process when made available to us. Please communicate in the meantime, that there is no survey to complete during March 2019, as previously scheduled.
