

AG/KEA/FOP to be heard by KY Supreme Court

Tomorrow, the KY Supreme Court will hear our case on the constitutionality of SB 151 (aka "the sewer bill"). There will only be 140 seats available in the court room. KET has agreed to televise this hearing live on their legislative channels via television as well as online. The proceedings will begin at 10 am ET and professional dress in the courtroom is expected. KEA will give live updates via our Facebook and Twitter pages as information becomes available. The Kentucky Public Pension Coalition has reserved a room for overflow viewing in the Capitol Annex also.

KDE SEEKING FEEDBACK ON REVISED SOCIAL STUDIES STANDARDS

The Kentucky Department of Education (KDE) is seeking feedback on the revised Kentucky Academic Standards for Social Studies. Senate Bill 1 (2017) calls for the Kentucky Department of Education to implement a process for reviewing all academic standards and aligned assessments with one or two content areas to be reviewed each year and every six years after that on a rotating basis. Beginning

Wednesday, August 29, and continuing through Thursday, September 27, anyone interested is invited to review the revised Kentucky Academic Standards for Social Studies to share feedback and suggestions for use during the remaining development process of the new standards. Feedback and comments will be thoughtfully considered, and any needed revisions made before bringing forward a final set of proposed standards to the Kentucky Board of Education for action later this year. The current schedule calls for implementation of revised social studies standards in the 2019-2020 school year. The last revision to social studies standards was in 2006. To provide feedback on the revised Kentucky Academic Standards for Social Studies, go to a special online site where you can read the standards and leave comments. Due to the amount of text within the survey, it is recommended that surveys be completed on a full-size computer or laptop. Questions on this process can be directed to standards@education.ky.gov

APPLICATIONS SOUGHT FOR CAREER STUDIES STANDARDS COMMITTEES

Applications are being accepted for the Career Studies Standards Review and Development Committees (RDCs) and Advisory Panels (APs). KRS 158.6453 calls for the review and revision of Kentucky's Academic Standards every six years. This year, standards for Career Studies (formerly Vocational Studies) will be reviewed and revised based upon the processes outlined in KRS 158.6453. KDE is seeking teachers of all grade levels and postsecondary educators to apply to participate in this work. Applicants will be required to meet in Frankfort for 2-4 days during the 2018-19 school year. Selected team members will receive reimbursement for travel expenses. Substitute teacher expenses will be reimbursed to the teacher's school district. Potential applicants are asked to verify the willingness of their school or district to release them for work dates throughout the school year. The online application will be posted for 30 days. Applications will be accepted through October 10. Selected team members will be notified shortly after that.
